TERMS & CONDITIONS - Fenagh Visitor Centre Bookings

Thank you for booking your party at Fenagh Visitor Centre.

The €25 you pay now is the room rental fee. This is a non-refunable and non-deductable fee. On top of this fee, we will charge you on the day per child. The price per child is €12 and includes play, crisps, juice, a kid's meal and ice lolly. Party bags cost an extra €3 per child.

The maximum number of children per party is 20 children. Children must be supervised at all times whilst in the Visitor Centre.

TERMS & CONDITIONS - YourDaysOut
