TERMS & CONDITIONS - Fenagh Visitor Centre Bookings

Thank you for booking your party at Fenagh Visitor Centre.

The €25 you pay now is the room rental fee. This is a non-refunable and non-deductable fee. On top of this fee, we will charge you on the day per child. The price per child is €12 and includes play, crisps, juice, a kid's meal and ice lolly. Party bags cost an extra €3 per child.

The maximum number of children per party is 20 children. Children must be supervised at all times whilst in the Visitor Centre.

Adult food options are extra. You can select these options on this form, and we will confirm your selection with you before the party.

The rules for the soft-play area are below:

- Parents and guardians must supervise children using this play facility.
- We provide members of staff who monitor the equipment and have access to first aid facilities. These staff are not provided to supervise children using the facilities.
- Children who are unwell must not use the facilities.
- Height and age restrictions are in force for the safety of all children and our staff will enforce them.
- Children must remove their shoes before playing on the equipment in the play area.
- For hygiene reasons, children should wear socks.
- No food, drinks, sweets or chewing gum are to be taken into play areas.
- Only plastic glasses/bottles are allowed in the supervison area. No drinks containers are to be taken into the play area.
- Smoking is not permitted.
- Pens, buckles, jewellery, watches, money, sharp objects etc. must not be taken into the play area by children using play equipment.
- Personal items must be left with parents/ guardians. We cannot accept liability for theft.

We advise you to bring a cake to the birthday party. We provide some decoration, but if you would like to provide more, that is allowed. We do not allow the following decoration items as they present a choking hazard:

- Non-helium balloons
- Piñatas
- Party poppers
- Streamers

TERMS & CONDITIONS - YourDaysOut
