Tickets valid for use any day over the next year (and beyond). Please check in advance that we are open due to on-going Covid restrictions.

- Open Daily: 10am - 4pm (Friday-Monday during winter periods)
- Last entry: strictly 3pm
- Admission free for children aged 2 and under

Unfortunately no pets are allowed, even guide dogs and service dogs are not permitted due to health and safety issues.

Children must be supervised at all times. Wild Ireland is pram and wheelchair friendly.

Only food purchased at our cafe may be brought to the picnic area, and food is restricted to certain areas within the park, and strictly prohibited outside of these areas near enclosures

It is totally forbidden to feed the animals. If you do so, you will be banned from Wild Ireland

TERMS & CONDITIONS - YourDaysOut
