Slide one at a time in a forward seated position, feet first.

Please no climbing on or up the slides.

Please no climbing or standing on the outside of the play equipment. Please no running, pushing, hitting or biting allowed.

Please no food, gum or drinks in the play equipment.

Only food and drink purchased on the premises may be consumed here. Please do not bring toys or other items into the play equipment.

If your child has a medical condition you must inform us before entering

Kidspace accepts no liability for supervision, loss, damage or injury to persons or property within the centre, this does not affect you statutory rights.

Height and age restrictions are in force for the safety of all the children, please respect them.

Please notify management of any concerns.

TERMS & CONDITIONS - YourDaysOut

YourDaysOut (YDO) is a SaaS platform that provides a Site and Services to Premium Business Partners, acting as an agent between the Customer (the person using the website and/or purchasing a ticket) and the Organiser (the person who is selling the ticket).
