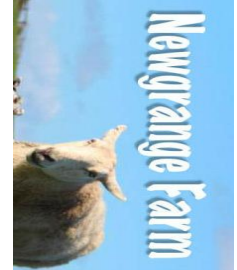

TERMS & CONDITIONS - YourDaysOut

Organisers, Customers and third parties using our Site and Services can be referred collectively as "Users," "you" or "your."
