Slide one at a time in a forward seated position, feet first.

Please no climbing on or up the slides.

Please no climbing or standing on the outside of the play equipment or netting.

Please no running, pushing, hitting or biting allowed.

Please no food, gum or drinks in the play equipment.

Only food and drink purchased on the premises may be consumed here. Please do not bring toys or other items into the play equipment.

If your child has a medical condition you must inform us before entering

Kidspace accepts no liability for supervision, loss, damage or injury to persons or property within the centre, this does not affect your statutory rights.

Height and age restrictions are in force for the safety of all the children, please respect them.

Please notify management of any concerns.

## TERMS & CONDITIONS - YourDaysOut

YourDaysOut (YDO) is a SaaS platform that provides a Site and Services to Premium Business Partners, acting as an agent between the Customer (the person using the website and/or purchasing a ticket) and the Organiser (the person who is selling the ticket).

The Organiser signs up with YDO as a Premium Business Partner and, via a login, is given access to the Site and Services on the platform whereby they have full control over the content of their Page.

YDO provides free access to the Site to the Customer. The Services available to the Customer are provided to the Customer pursuant to the [User Agreement](#) and YDO reserves the right to publish additional operating rules or policies from time to time.

Organisers, Customers and third parties using our Site and Services can be referred collectively as "Users," "you" or "your."

YDO acts as a data processor on behalf of the Organiser (data controller). Refunds from event organisers may include the value of the ticket, less any booking and processing fees, which will constitute full remuneration.

YourDaysOut or the organiser, are not responsible for any inconvenience caused by unauthorised duplication. In the event that duplicate copies appear, the organiser/venue reserves the right to refuse entry to all ticket holders and may refund the original purchaser the value of the ticket, less any admin and processing fees, which will constitute full remuneration.
