By attending Kidspace on the day you have booked, you confirm that:

- you, your children, or any guests have not been ill in the last 24 hours before attendance

- you, your children, or any guests have not had a temperature in the last 24 hours before attendance

This event is suitable for kids and their guardians are welcome to book on to this 90 minute session should they wish - just book a Player Ticket for anyone that wants play.

Otherwise, children are welcome to be dropped off as our staff will be on hand to supervise.

Adults can also pay €2 and enjoy the fun from our Nest Cafe. We will be open for hot and cold beverages and snacks.

Laser and strobe lighting is used during this activity.

The environment can be loud with the sounds of music and kids playing. A waiver must be signed in advance.

## TERMS & CONDITIONS - YourDaysOut

YDO acts as a data processor on behalf of the Organiser (data controller). Any information or data, transactional

or otherwise, about the Organiser's customers (the Data) which the Organiser obtains through the customer purchasing tickets on YDO, is the property and the responsibility of the Organiser and shall be stored by YDO only for the exclusive use of the Organiser.

YDO is not the organiser or owner of the events listed on the Site. Rather, YDO provides its Services, which allow Users to create events, manage ticketing and registration and promote their events. Refunds from event organisers may include the value of the ticket, less any booking and processing fees, which will constitute full remuneration.

Keep this ticket in a safe place, as you would money or a regular ticket. YourDaysOut or the organiser do not accept any responsibility for loss or damage to your ticket. YourDaysOut or the organiser, are not responsible for any inconvenience caused by unauthorised duplication.
