Laser Quest: Terms and Conditions

By attending Kidspace on the day you have booked, you confirm that:

- you, your children, or any guests have not been ill in the last 24 hours before attendance
- you, your children, or any guests have not had medication in the last 24 hours before attendance
- you, your children, or any guests have not had a temperature in the last 24 hours before attendance

This event is suitable for kids and their guardians are welcome to book on to this 90 minute session should they wish - just book a Player Ticket for anyone that wants play.

Otherwise, children are welcome to be dropped off as our staff will be on hand to supervise.

Adults can also pay €2 and enjoy the fun from our Nest Cafe. We will be open for hot and cold beverages and snacks.

Laser and strobe lighting is used during this activity.

The environment can be loud with the sounds of music and kids playing. A waiver must be signed in advance.

TERMS & CONDITIONS - YourDaysOut

Refunds from event organisers may include the value of the ticket, less any booking and processing fees, which will constitute full remuneration.

YourDaysOut or the organiser, are not responsible for any inconvenience caused by unauthorised duplication.
