Booking online, three days in advance only. If you party is less than three days away, please contact the centre. There is no guarantee that your party can be arranged at short notice.

By attending Kidspace Rathcoole on the day you have booked, you confirm that:

- you, your children or any guests have not been ill in the last 24 hours before attendance

Please arrive and exit on time.

Kidspace will reserve a table and four chairs for the duration of the party in the Nest Café for parents and we will provide drinks here for the children during their play time.

Reserved tables in the play frame area are for Toddler Parties ONLY.
