Booking online, three days in advance only. If you party is less than three days away, please contact the centre. There is no guarantee that your party can be arranged at short notice.

By attending Kidspace Rathcoole on the day you have booked, you confirm that:

- you, your children or any guests have not been ill in the last 24 hours before attendance
- you, your children or any guests have not had medication in the last 24 hours before attendance
- you, your children or any guests have not had a temperature in the last 24 hours before attendance
- All attending adults have been vaccinated and will present CoVid-19 vaccination certs before admission.

Capacity will be limited as per government guidelines.

Minimum party booking is for 10 children. Due to current government restrictions, we can only accommodate maximum of 25 people per booking, including adults. Please let us know at the time of booking if you anticipate your numbers being more than this.

Please arrive and exit on time.

Kidspace will reserve a table and four chairs for the duration of the party in the Nest Café for parents and we will provide drinks here for the children during their play time.

Reserved tables in the play frame area are for Toddler Parties ONLY.

Kidspace provides all food, drinks and sweets for each party. Only food purchased in Kidspace can be consumed on the premises. No additional treats are to be consumed in the Party Room or the Café. Only the parents of the birthday child(ren) are allowed in the party room at the time of the party.

Children are not permitted re-enter the play frame after they have had their food in the party room.

We require a non-refundable deposit of €100 for all parties. This deposit will be deducted from your balance on the day of the party.

Party bags are only suitable for children aged 3 years +. Staff members should be notified of any children that are under this age and are due to receive party bags.

Only food and drink purchased on the premises may be consumed here.

Please do not bring toys or other items into the play equipment.

If your child has a medical condition you must inform us before entering.

Kidspace accepts no liability for supervision, loss, damage or injury to persons or property within the centre, this does not affect your statuary rights.

Height and age restrictions are in force for the safety of all the children, please respect them.
