Booking online, three days in advance only. If you party is less than three days away, please contact the centre. There is no guarantee that your party can be arranged at short notice.

## By attending Kidspace Rathcoole on the day you have booked, you confirm that:

- you, your children or any guests have not been ill in the last 24 hours before attendance
- you, your children or any guests have not had medication in the last 24 hours before attendance
- you, your children or any guests have not had a temperature in the last 24 hours before attendance

Please arrive and exit on time.

Kidspace will reserve a table and four chairs for the duration of the party in the Nest Café for parents and we will provide drinks here for the children during their play time.

Reserved tables in the play frame area are for Toddler Parties ONLY.

Kidspace provides all food, drinks and sweets for each party. Only food purchased in Kidspace can be consumed on the premises. No additional treats are to be consumed in the Party Room or the Café. Only the parents of the birthday child(ren) are allowed in the party room at the time of the party.

Children are not permitted re-enter the play frame after they have had their food in the party room.
