Booking online, three days in advance only. If you party is less than three days away, please contact the centre.

Please arrive and exit on time.

Kidspace will reserve a table and four chairs for the duration of the party in the Nest Café for parents and we will provide drinks here for the children during their play time.

Reserved tables in the play frame area are for Toddler Parties ONLY.
