By attending Kidspace Rathcoole on the day you have booked, you confirm that:

- you, your children, or any guests have not been ill in the last 24 hours before attendance
- you, your children, or any guests have not had medication in the last 24 hours before attendance
- you, your children, or any guests have not had a temperature in the last 24 hours before attendance
- Adults must be booked in advance. The first four are free and any additional adults are charged at €2 each.
- Please arrive at your designated time slot.
- Please leave immediately at the end of your time slot
- Your party could be one of 8 parties being catered for in Rathcoole and one of 5 in Rathfarnham, as well as general customers on the premises. Weekends are our peak times for birthday parties and play.
- Minimum party booking is for 10 children.
- Please arrive at your designated time slot.
- Please leave immediately at the end of your time slot.
- Kidspace will reserve a table for a minimum of 4 adults.
- Kidspace provides all food, drinks, and sweets for each party. Only food purchased in Kidspace can be consumed on the premises.
- Balloons are available for purchase, and we do not permit parties to bring their own balloons or decorations.
- Party Bags are NOT provided. You are welcome to bring your own should you wish to.
- Only the parents of the birthday child(ren) are allowed in the party area at the time of the party. Please note that the Harry Potter and Lego party rooms are located upstairs in Kidspace Rathcoole.
- Pamper Parties are child centered and child friendly. We offer child appropriate treatments (we are not a spa). We are not responsible for any allergies/ reactions to the products we use.

- Height and age restrictions are in force for the safety of all the children, please respect them.
