Booking online, three days in advance only. If you party is less than three days away, please contact the centre. There is no guarantee that your party can be arranged at short notice.

Please contact the centre ASAP if you have more than 16 children attending.

By attending Kidspace Rathfarnham on the day you have booked, you confirm that:

- you, your children or any guests have not been ill in the last 24 hours before attendance
- you, your children or any guests have not had medication in the last 24 hours before attendance

Kidspace will reserve a table and four chairs for the duration of the party in the Nest Café for parents and we will provide drinks here for the children during their play time.

Reserved tables in the play frame area are for Toddler Parties ONLY.

Kidspace provides all food, drinks and sweets for each party. Only food purchased in Kidspace can be consumed on the premises. Only the parents of the birthday child(ren) are allowed in the party area at the time of the party.

Children are not permitted re-enter the play frame after they have had their food.

We require a non-refundable deposit of €100 for all parties. This deposit will be deducted from your balance on the day of the party.

Height and age restrictions are in force for the safety of all the children, please respect them.
