Please contact the centre ASAP if you have more than 16 children attending.

By attending Kidspace Rathfarnham on the day you have booked, you confirm that:

- you, your children or any guests have not been ill in the last 24 hours before attendance
- you, your children or any guests have not had medication in the last 24 hours before attendance
- you, your children or any guests have not had a temperature in the last 24 hours before attendance

Capacity will be limited as per government guidelines.

Minimum party booking is for 10 children.

Adults must be booked in advance. The first four are free, but any additional adults are charged at €2 each.

Any valid coupon code will be applied when you settle the balance of your booking on the day of the party.

Only codes entered during the active valid period will be considered.

Your party could be one of 3 parties being catered for in Rathfarnham, as well as general customers on the premises.

Kidspace will reserve a table and four chairs for the duration of the party in the Nest Café for parents and we will provide drinks here for the children during their play time.

Reserved tables in the play frame area are for Toddler Parties ONLY.

Kidspace provides all food, drinks and sweets for each party. Only food purchased in Kidspace can be consumed on the premises.

Party Bags are not provided. You are welcome to bring your own should you wish to.

Height and age restrictions are in force for the safety of all the children, please respect them.
