Any valid coupon code will be applied when you settle the balance of your booking on the day of the party.

Only codes entered during the active valid period will be considered.

Your party could be one of 3 parties being catered for in Rathfarnham, as well as general customers on the premises.

Kidspace will reserve a table and four chairs for the duration of the party in the Nest Café for parents and we will provide drinks here for the children during their play time.

Reserved tables in the play frame area are for Toddler Parties ONLY.

Kidspace provides all food, drinks and sweets for each party. Only food purchased in Kidspace can be consumed on the premises.

Party Bags are not provided. You are welcome to bring your own should you wish to.

Only the parents of the birthday child(ren) are allowed in the party area at the time of the party.

Children are not permitted re-enter the play frame after they have had their food.

We require a non-refundable deposit of €100 for all parties. This deposit will be deducted from your balance on the day of the party.

All parties must notify reception of their departure after the party and the balance must be paid at this time.

If your child has a medical condition you must inform us before entering.

Kidspace accepts no liability for supervision, loss, damage or injury to persons or property within the centre, this does not affect your statuary rights.

Height and age restrictions are in force for the safety of all the children, please respect them.
