Only one party will be booked at this time. There will be no other children in the play centre. Capacity will be limited to 50 people indoors. Booking online, three days in advance only. Minimum party booking is for 12 children.

TERMS & CONDITIONS - Birthday Party Bookings | Kidspace Rathcoole

Your party is 2 hours in duration – 90 minutes play and 30 minutes in the Party Room. Please respect these times as we have other parties to cater for.

Kidspace will reserve a table and four chairs for the two hours of the party in the Nest Café for parents and we will provide drinks here for the children during their play time. Reserved tables in the play frame area are for Toddler Parties ONLY.

Kidspace provides all food, drinks and sweets for each party. Only food purchased in Kidspace can be consumed on the premises. No additional treats are to be consumed in the Party Room or the Café.
