### TERMS & CONDITIONS - Kidspace Rathcoole | General Admission

Passes are valid for both centres (Rathfarnham AND Rathcoole) and include activity mornings.

All Week passes are valid for any session, Wednesday - Sunday.

Monthly Passes are NOT valid during school holidays.

Staff will add on any time missed because of holidays.

Please select the date of your first visit. Your month starts from this date. If your first date is after this, Kidspace will count your first day from the date of your first check-in.

All Week Monthly Pass is €45 per child with any additional sibling only €20.

Monthly Pass includes 1 adult per pass. Additional adults charged €2 on arrival.

### TERMS & CONDITIONS - YourDaysOut

YourDaysOut (YDO) is a SaaS platform that provides a Site and Services to Premium Business Partners, acting as an agent between the Customer (the person using the website and/or purchasing a ticket) and the Organiser (the person who is selling the ticket).

The Organiser signs up with YDO as a Premium Business Partner and, via a login, is given access to the Site and Services on the platform whereby they have full control over the content of their Page.

Organisers, Customers and third parties using our Site and Services can be referred collectively as "Users," "you" or "your."

Users agree to indemnify, defend (at YDO's request), and hold YDO, its parent, subsidiaries, affiliates, shareholders, officers, directors and employees, harmless from any claim or demand, including reasonable legal

As all transactions are between an Organiser and its respective attendees, YDO asks that all Customers contact the applicable Organiser of their event or activity with any refund requests. Refunds from event organisers may include the value of the ticket, less any booking and processing fees, which will constitute full remuneration.

Keep this ticket in a safe place, as you would money or a regular ticket. YourDaysOut or the organiser do not accept any responsibility for loss or damage to your ticket. YourDaysOut or the organiser, are not responsible for any inconvenience caused by unauthorised duplication.
