Meeting in Newgrange Farm at 12:30 on day of tour. **Eircode: C15 X5EV** Free parking is available at the farm.

The tour of the Newgrange monument will include a visit to the interior chamber with OPW guides followed by a guided tour of the Newgrange Farm Archaeological Park on a tractor-hauled specially modified trailer, where tour participants will get a close-up glimpse of ancient passage-tombs, henges, standing stones and other remarkable features of the ancient past.

Following the tour, guests can visit the working farm and cafe.

The tour will take approximately 4 hours.

This tour is NOT weather dependent as it includes a tour of the internal chamber of the Newgrange monument and the trailer is covered. However, this is Ireland so please bring clothes to suit all weather.

Unfortunately, this tour is not wheelchair accessible.

### TERMS & CONDITIONS - YourDaysOut
