The tour of the Newgrange monument will include a visit to the interior chamber with OPW guides followed by a guided tour of the Newgrange Farm Archaeological Park on a tractor-hauled specially modified trailer, where tour participants will get a close-up glimpse of ancient passage-tombs, henges, standing stones and other remarkable features of the ancient past.

Following the tour, guests can visit the working farm and cafe.

The tour will take approximately 4 hours.

This tour is NOT weather dependent as it includes a tour of the internal chamber of the Newgrange monument and the trailer is covered. <u>However, this is Ireland so please bring clothes to suit all weather.</u>
