• Terms and Conditions:

- There will be two sessions each day 10:30am to 1:30pm and 2pm to 5pm.
- Please arrive at the specific day and time of your booking with a copy of your booking confirmation and your voucher, these can be on your phone or printed out.
- Children must be accompanied by an adult at all times. Children under 12 months are free and do not require a ticket.
- Please comply with all directions from our staff and signage.
- Takeaway teas, coffees, snacks, soft drinks and ice creams are available from our coffee shop. Picnics are welcome.
- Visitors should note that our blue barrel and horse and carriage rides are available at a limited capacity per spin.
- Tickets must be brought along to the reception and presented either as a print out or on your phone.
- Tickets are non-refundable. Any change of date or time will require at least 48 hours' notice (notice to be given during our opening times of 10:30am and 5pm and will not be accepted as being given when we are closed) and will be subject to availability. No changes or cancellations will be put in place after the time and date has passed

TERMS & CONDITIONS - YourDaysOut

YourDaysOut (YDO) is a SaaS platform that provides a Site and Services to Premium Business Partners, acting as an agent between the Customer (the person using the website and/or purchasing a ticket) and the Organiser (the person who is selling the ticket).

Any information or data, transactional or otherwise, about the Organiser's customers (the Data) which the Organiser obtains through the customer purchasing tickets on YDO, is the property and the responsibility of the Organiser and shall be stored by YDO only for the exclusive use of the Organiser.

YDO is not the organiser or owner of the events listed on the Site. Rather, YDO provides its Services, which allow Users to create events, manage ticketing and registration and promote their events. Refunds from event organisers may include the value of the ticket, less any booking and processing fees, which will constitute full remuneration.

YourDaysOut or the organiser, are not responsible for any inconvenience caused by unauthorised duplication.
