Kids from 4-10 years will gather under the Disco lights with our professional dance teacher and interactive DJ, who will lead the kids in some funky dance moves to keep them boogying the morning away!

Each child (or adult!) who participates will receive special wireless headphones which allows them to control their own music volume, making it a totally safe, kid friendly experience.

This can be helpful for kids with sensory needs who enjoy the disco experience but find loud music overwhelming. As well as the latest hits, we will have our laser and disco lights creating the perfect party atmosphere.

Kidspace will be closed to the public from 10-11am so our Silent Disco Divas can enjoy the playcentre to themselves and from 11am-12noon there will be time to enjoy all the fun of the playcentre including our 4 slides, 5 ball pools, race track, zipline and our pamper parlour will be open for treatments.

While the kids have fun parents can relax in our Nest Café which will be open for delicious coffees and snacks as well as bunch and lunch options.

By attending Kidspace on the day you have booked, you confirm that:

- you, your children, or any guests have not been ill in the last 24 hours before attendance
- you, your children, or any guests have not had medication in the last 24 hours before attendance
- you, your children, or any guests have not had a temperature in the last 24 hours before attendance
- Tickets are non-refundable
- Events includes time in the playframe. Check booking info for timings and age suitability.
- Adults must purchase a ticket for €2 to accompany their child and it is their responsibility to supervise children in their care at all times when attending an event.
- Only 1 adult will be permitted into the area where the event is happening due to space restrictions. Additional adults will be able to join for a photo opportunity

Laser and strobe lighting may be used during the activity.

The environment can be loud with the sounds of music and kids' playing. A waiver must be signed in advance.

TERMS & CONDITIONS - YourDaysOut
