- We operate a self-supervised facility and parents & guardians are responsible for children in their care at all times.
- We take all reasonable steps to ensure Tearaways Pet Farm & Activity Centre is as safe as possible, but the nature of children's play means that accidents can occasionally happen. Children must be supervised by an Adult at all times and rules must be followed.
- No liability will be accepted for any injury, damage or loss while on these premises.

Gift Cards / Loyalty Cards

One FULL Loyalty card per child must be presented on arrival or full amount is payable.

TERMS & CONDITIONS - YourDaysOut

YourDaysOut (YDO) is a SaaS platform that provides a Site and Services to Premium Business Partners, acting as an agent between the Customer (the person using the website and/or purchasing a ticket) and the Organiser (the person who is selling the ticket).

Refunds from event organisers may include the value of the ticket, less any booking and processing fees, which will constitute full remuneration.

YourDaysOut or the organiser, are not responsible for any inconvenience caused by unauthorised duplication.
