## TERMS & CONDITIONS - Kidspace Rathfarnham | Events

**Please contact [support@yourdaysout.com](mailto:support@yourdaysout.com) with any booking queries**

By attending Kidspace on the day you have booked, you confirm that:

- you, your children, or any guests have not been ill in the last 24 hours before attendance
- you, your children, or any guests have not had medication in the last 24 hours before attendance
- you, your children, or any guests have not had a temperature in the last 24 hours before attendance
- Tickets are non-refundable
- Events includes time in the playframe. Check booking info for timings and age suitability.
- Adults must purchase a ticket for €2 to accompany their child and it is their responsibility to supervise children in their care at all times when attending an event.
- Only 1 adult will be permitted into the area where the event is happening due to space restrictions. Additional adults will be able to join for a photo opportunity

Laser and strobe lighting may be used during the activity.

The environment can be loud with the sounds of music and kids' playing. A waiver must be signed in advance.

## TERMS & CONDITIONS - YourDaysOut

YourDaysOut (YDO) is a SaaS platform that provides a Site and Services to Premium Business Partners, acting as an agent between the Customer (the person using the website and/or purchasing a ticket) and the Organiser (the person who is selling the ticket).

YDO acts as a data processor on behalf of the Organiser (data controller). Any information or data, transactional or otherwise, about the Organiser's customers (the Data) which the Organiser obtains through the customer purchasing tickets on YDO, is the property and the responsibility of the Organiser and shall be stored by YDO only for the exclusive use of the Organiser.

YDO is not the organiser or owner of the events listed on the Site. Rather, YDO provides its Services, which allow Users to create events, manage ticketing and registration and promote their events. The Organiser is solely responsible for ensuring that any page displaying their event on the Services (and the event itself) meet all applicable local, state, provincial, national and other laws, rules and regulations, and that the goods and services described on the event page are delivered as described and in an accurate satisfactory manner. Customers must use Stripe payment processing when purchasing a ticket and YDO.

If you wish to transfer tickets to an event you have purchased on YDO, please contact the Organiser of the event.

As all transactions are between an Organiser and its respective attendees, YDO asks that all Customers contact the applicable Organiser of their event or activity with any refund requests. Refunds from event organisers may include the value of the ticket, less any booking and processing fees, which will constitute full remuneration.

Keep this ticket in a safe place, as you would money or a regular ticket. YourDaysOut or the organiser do not accept any responsibility for loss or damage to your ticket. YourDaysOut or the organiser, are not responsible for any inconvenience caused by unauthorised duplication. In the event that duplicate copies appear, the organiser/venue reserves the right to refuse entry to all ticket holders and may refund the original purchaser the value of the ticket, less any admin and processing fees, which will constitute full remuneration.
