## TERMS & CONDITIONS - YourDaysOut

Refunds from event organisers may include the value of the ticket, less any booking and processing fees, which will constitute full remuneration.

YourDaysOut or the organiser, are not responsible for any inconvenience caused by unauthorised duplication. In the event that duplicate copies appear, the organiser/venue reserves the right to refuse entry to all ticket holders and may refund the original purchaser the value of the ticket, less any admin and processing fees, which will constitute full remuneration.
