Admission free for children aged under 2.

Unfortunately no pets are allowed, even guide dogs and service dogs are not permitted due to health and safety issues.

Children must be supervised at all times. Wild Ireland is pram and wheelchair friendly.

Only food purchased at our shop may be brought to the picnic area, and food is restricted to certain areas within the park, and strictly prohibited outside of these areas near enclosures

It is totally forbidden to feed the animals. If you do so, you will be banned from Wild Ireland.

TERMS & CONDITIONS - YourDaysOut

YourDaysOut (YDO) is a SaaS platform that provides a Site and Services to Premium Business Partners, acting as an agent between the Customer (the person using the website and/or purchasing a ticket) and the Organiser (the person who is selling the ticket).

The Organiser signs up with YDO as a Premium Business Partner and, via a login, is given access to the Site and Services on the platform whereby they have full control over the content of their Page.

Organisers, Customers and third parties using our Site and Services can be referred collectively as "Users," "you" or "your."

Users agree to indemnify, defend (at YDO's request), and hold YDO, its parent, subsidiaries, affiliates,

As all transactions are between an Organiser and its respective attendees, YDO asks that all Customers contact the applicable Organiser of their event or activity with any refund requests. Refunds from event organisers may include the value of the ticket, less any booking and processing fees, which will constitute full remuneration.

Keep this ticket in a safe place, as you would money or a regular ticket. YourDaysOut or the organiser do not accept any responsibility for loss or damage to your ticket. YourDaysOut or the organiser, are not responsible for any inconvenience caused by unauthorised duplication.
